The undersigned (individual) (partnership) (corporation) (limited liability company) hereby makes application to the Supervisor of Alcohol and Tobacco Control of the State of Missouri for an annual wine direct shipper license pursuant to Section 311.185, RSMo. Applicant agrees that if the license herein applied for is granted, and the licensee shall violate any law of the State of Missouri and particularly any provision of the Liquor Control Law and amendments thereto or any Rule or Regulation of the Supervisor of Alcohol and Tobacco Control or permit any other person to do so upon the premises, the Supervisor may suspend, revoke, fine, or take other disciplinary action against the license. Applicant also agrees that he will file a copy of its current alcoholic beverage license issued in this state or any other state, and a copy of the winery license from the Alcohol and Tobacco Tax and Trade Bureau pursuant to Section 311.185.1, RSMo.

Applicant also agrees that he must follow the standards that must be followed by a wine direct shipper licensee, file annual excise tax report and remit payment annually, and permit audits by the Division of Alcohol and Tobacco Control pursuant to Section 311.185.2, RSMo.

Applicant also agrees that he must renew this license annually by providing the same as required in Section 311.185.1, RSMo.
